WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF

GREENVILLE, in the full and just sum of Seventy One Thousand and no/100... (\$ 71,000.00 Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

Office for Greenville County in Plat Book A at Page 383 and having according to a more recent survey prepared for East Park Baptist Church by Piedmont Engineering Service dated June 9, 1949 revised July 11, 1958 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Ebaugh Avenue, joint front corner Lots Nos. 76 and 77 and running thence with the joint line of said lots, N. 73-30 E. 185.5 feet to an iron pin in the line of Lot No. 74; thence with the line of Lot No. 74, N. 48-30 W. 77.3 feet to an iron pin; thence with a new line through Lot No. 74, N. 18-59 W. 49.3 feet to an iron pin; thence N. 73-30 E. 127.9 feet to an iron pin on the Southwestern side of Laurens Road; thence with Laurens Road, N. 62-30 W. 36.5 feet to an iron pin in the right-of-way of the C & WC Railroad; thence with said right-of-way, S. 73-30 W. 366.4 feet to an iron pin on the Northern side of Ebaugh Street; thence with Ebaugh Street, S. 57-00 E. 199.7 feet to the beginning corner.
