"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, near the Town of Greer, and designated as Lot No. 12 on plat of the W.C. Smith Property, prepared by H.S. Brockman, Surveyor, May 25, 1936, and thereon delineated as follows, to-wit:
