All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, and being known and designated as Lot No. 32 according to a plat of Elizabeth Heights, plat made by C. M. Furman, Jr., April, 1925, which plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book F, at page 298, and having according to said plat the following metes and bounds, to-wit:
