NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Butler Township, Greenville County, State of South Carolina, being known and designated as Lot No. 39, as shown on a plat prepared by Piedmont Engineering Service, dated November, 1955, entitled "Plat of Lake Forest Heights, Section 1", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book GG at page 153, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Scotland Circle at the joint corner of Lots Nos. 39 and 40, and running thence with the line of Lot No. 40 S. 7-26 E. 166.5 feet to an iron pin at the joint corner of Lots Nos. 37, 39 and 40; thence with the line of Lot No. 37 S. 14-51 W. 27 feet to an iron pin at the joint corner of Lots Nos. 37, 38 and 39; thence with the line of Lot No. 38 N. 68-55 W. 167.2 feet to an iron pin on the Eastern side of Scotland Circle; thence with the Southeastern side of Scotland Circle, and following the curve thereof, the following courses and distances: N. 37-03 E. 55 feet to an iron pin, N. 44-40 E. 70 feet to an iron pin, N. 57-36 E. 70 feet to the point of beginning.
