"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, located on the City limit line of the City of Greer, just outside the limits, on Maple Creek just off State Highway No. 14 on the north side of Lee Circle and being known as Lot No. 14 on a plat of property entitled Maple Heights, made for the Lee G.
