"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Hammett Street in the Town of Piedmont, and being shown as lot 81 on a plat of the property of Piedmont Manufacturing Company, recorded in Plat Book Y at page 9, and described as follows:
