WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs

Township, near the coporate limits of the City of Greer and North therefrom, known and designated as Lot No. 31 on a plat of property of Brookwood Subdivision, prepared by B.B.Waters, Jr., Surveyor, dated October 14, 1958, recorded in the R.M.C.Office for Greenville County in Plat Book QQ, at page 21, having the following courses and distances:

BEGINNING AT an iron pin on the East side of Brookwood Drive, joint front corner of Lots Nos. 31 and 32, and runs thence S. 87-27 E. 367 feet to an iron pin; thence N. 2-48 E. 102.5 feet to an iron pin; thence N. 1.08 E. 84.8 feet to an iron pin; thence S. 85.06 W. 370.2 feet to an iron pin on the East side of Brookwood Drive; thence along the East side of Brookwood Drive S. 1-20 E. 51.4 feet and S. 2-33 W. 87 feet to the beginning, and being all of that lot of land conveyed to the mortgagors by G. and Alice S. Hayes, by deed dated October 24, 1958, recorded in the R.M.C.Office for Greenville County in Deed Book 609, at page 250.
