All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Western side of St. Mark's Road about one (1) mile North of Chick Springs, Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 1, 2 and 3, as shown on a plat prepared by H.L. Dunahoo, Surveyor, dated November 18, 1946, entitled "Property of John H. McConnell", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book Q at page 79, and having according to said plat the following metes and bounds:
