C. Chastain, made by W. J. Riddle, October 1951, recorded in the RMC Office for Greenville County in Plat Book AA, page 175 and shown on the Greenville County Auditor's Bleck Book on Sheet 162, Block 2, Lot 66 and being more particularly described, as follows:

BEGINNING at an iron pln on the west side of Chastain Drive, the joint corner of Lots Nos. 7 and 8 themse with the west side of Chastain Drive, 8. 2-34 E. 62.9 feet to an iron pin; thence S. 88-00 W. 343 feet to an iron pin; thence N. 6-00 E. 77.8 feet to an iron pin, corner of Lot No. 7; thence with the line of said lot, S. 89-15 E. 332 feet to the beginning corner.
