

E. H. Edwards, his heirs and assigns forever:

All that certain piece, parcel or tract of land, lying and being in the County and State aforesaid, about one mile northwest from Batesville, lying on the northe side of Brushy Creek and on the West side of the Augusta Road, and being the same tract of land conveyed to me by dded from Roy Wendell Phillips, and having the following courses and distances, to-wit:

BEGINNING at a point in the center of the Bridge over Brush Creek and the Augusta Road, and runs thence with the center of the said road as the line to a point where the road crosses the dividing line and the DeShields tract and Payne tract (two Tracts now or formerly owned by Roy Wendell Phillips); thence with the dividing line of the said two tracts S. 64.30 %. 435 feet to a stone; thence S. 73.45 W. 1002 feet to a stone; thence S. 81.15 W. 310 feet to the stone on Brushy Creek; thence down and with the said Creek as the line to the point of beginning, and containing by estimation thirty (30) acres, more or less.
