in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. E. Robinson, as Trustee under B. M. McGee Will, his Successors and Assigns forever:

All those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of Courtney Circle and being known and designated as Lot No. 72 and the major portion of Lot No. 71 of Casa Loma Estates as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "S", Page 65 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Courtney Circle at the joint front corner of Nos. Nos. 72 and 73 and running thence along the curve of Courtney Circle, the chord of which is S. 71-34 E. 90.1 feet to an iron pin, joint front corner of Lots Nos. 71 and 72; thence continuing with the curve of said Circle, the chord of which is S. 39-04 E. 84.1 feet to an iron pin in the front line of Lot No. 71; thence in a new line along the property previously conveyed to J. G. and Mary Mann S. 57 W. 124.9 feet to an iron pin; thence S. 51-30 W. 80.3 feet to an iron pin in the rear line of Lot No. 71; thence N. 51-40 W. 13.4 feet to an iron pin, joint rear corner of Lots Nos. 71 and 72; thence N. 51-40 W. 35 feet to an iron pin; thence along the joint line of Lots Nos. 72 and 73 N. 20-31 E. 192.5 feet to the point of beginning.
