"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

At the southeast corner of Allen Street and Kelly Street, near the City of Greenville, being shown as lot # 49 of Section 3 on a plat of Dunean Mill Village, recorded in Plat Book S. at Page 175, and described as follows;

BEGINNING at a stake at the southeast corner of Allen and Kelly Streets, and running thence with the southern side of Kelly Street, S. 64-15 E. 148.9 feet to a stake on an alley; thence with said alley, S. 25-49 W. 82.1 feet to a stake at the corner of lot # 48; thence with the line of said lot, N. 64-15 W. 149.1 feet to a stake on Allen Street; thence with the eastern side of said street, N. 25-52 E. 82.1 feet to the beginning corner.
