"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the western side of Brockman Avenue, near the City of Greenville, being lot No. 8 as shown on plat of property of Vivian Q. Guion, recorded in Plat Book C at page 131, and an adjoining triangular portion of Lot No. 24 as shown on plat of Sans Souci Villa, recorded in Plat Book A at page 510, and described as follows:

BEGINNING at a stake on the Western side of Brockman Avenue, 121 feet North from Young Street at corner of Lot No. 7 as shown on plat of property of Vivian Q. Guion, and running thence with the line of said lot, N. 57-25 W. 163.4 feet to a stake in line of Lot No. 5; thence with the line of said lot, N. 12--00 E. 60 feet to stake; thence S. 69-30 E. 149.6 feet to a stake on Brockman Avenue; thence with the Western side of Brockman Avenue, S. 10-30 W. 96 feet to the beginning cofner.
