We, Hugh C. Leary and Victoria M. Leary of Greenville County

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF

GREENVILLE, in the full and just sum of Twelve Thousand and no/100..... (\$12,000.00 Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Eighty Four and 26/100.....(\$84.26 each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. BEGINNING at an iron pin on the northeast side of Nora Drive, joint front corner of Lots 7 and 8, and running thence N. 79-10 E. 190 feet to an iron pin in line of Lot No. 14, joint rear corner of Lots 7 and 8; thence turning and running along line of Lot 14, S. 10-50 E. 90 feet to an iron pin joint rear corner of Lots 8 and 9; thence turning and running along joint line of said lots S. 79-10 W. 190 feet to an iron pin on the Northeast side of Nora Drive joint front corner of Lot 8 and 9; thence turning and running along the Northeast side of Nora Drive N. 10-50 W. 90 feet to an iron pin, the point of beginning; being the same property conveyed to us by Harold E.
