B. Dalton made by the Piedmont Engineering Service, November 11, 1949, recorded in Plat Book "DD" at page 157 in the Office of Register of Mense Conveyance, State and County aforesaid

BEGINNING at a point on Southern side of said County Road, joint front corner with Lot #10 of said plat, same heretofore convyed to Smith, and running thence S-26-40 W 120 feet (new corner) thence N-65-53 W 80 feet to iron pin.
