All that lot of land in Greenville County, State of South Carolina, on the Southern side of North Haven Lrive, near the City of Greenville, being shown as lot # 28 on a plat of the property of Buncombe Park, recorded in Plat Book M at Page 12, and described as follows:

BEGINNING at an iron pin on the Southern side of North Haven Drive, 630 feet East from Old Buncombe Road, at corner of lot # 29, and running thence with the southern side of said Drive, N. 88-00 E. 75 feet to iron pin, corner of lot # 27; thence with the line of said lot, S. 3-20 E. 173 feet to iron pin in line of lot # 12; thence with the line of said lot, S. 88-00 W. 75 feet to iron pin, corner of lot # 29; thence with the line of said lot, N. 3-20 W. 173 feet to the beginning corner.
