NOW, THEREFORE, in order to induce The Lincoln National Life Insurance Company, Fort Wayne, Indiana, to complete the purchase of said mortgage and for other good and valuable consideration, receipt of which is hereby acknowledged, the undersigned, Wooten Corporation of Wilmington, hereby agrees that the following provisions shall be considered as added to and incorporated in the aforesaid mortgage and that they shall have the same force and effect as if they had been included therein at the time the instrument was executed:

As further security for said mortgage loan, mortgagor has, coincident herewith, assigned to mortgagee that certain lease dated the 10th day of February, 1958, as amended, executed by Wooten Corporation of Wilmington, as lessor, and The Hilton-Davis Chemical Co., as lessee, and mortgagor covenants and agrees to perform promptly all of the covenants and agreements of said lease that are to be performed by the lessor and agrees that violation on lessor's part of any covenant or agreement set out in said assignment or in said lease to be kept or performed by lessor shall consitute a breach of this mortgage, and thereupon mortgagee may, at its option, without notice, declare the entire principal debt immediately due and pay-
