"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, at the Southeast corner of the intersection of North Brown Street and Beattie Place, and being shown on Plat recorded in Plat Book SS, at page 89, R M.C Office for Greenville County, and having the following metes and bounds: BEGINNING at an iron pipe at the Southeast corner of said intersection, and running thence with Beattie Place, S. 59-15 E. 85.45 feet to a stake in the center of an 8-inch concrete block wall, corner of property being conveyed to J. Mack Woods; thence through the center line of said wall, S. 30-30 W. 25 feet, more or less, to a stake in line of property of C. A.
