NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, sparcels or los of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the Southeast side of Mt. Eustis Street (also referred to as Beattie St.) in the City of Greenville, being shown as Lots 21 and 22 on a plat of F. F. Beattie Subdivision, recorded in Plat Book C at 236 and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the Southeast side of Mt. Eustis Street, joint front corner of Lots 22 and 23, which pin is 80 feet Southwest of the intersection of said street with Summitt Street, and running thence with the Southeast side of said Street, S. 52 W. 80 feet to an iron pin, joint front corner of Lots 20 and 21; thence with the line of said lots, S. 42-20 E. 100 feet to an iron pin; thence with the rear line of Lots 21 and 22, N. 52 E. 80 feet to an iron pin, joint rear corner of Lots 22 and 23; thence with the line of said lots, N. 42-20 W. 100 feet to the Beginning corner.
