All that piece, parcel or lot of land in O'Neal Township, Greenvill County, State of South Carolina, lying on the east side of the Greer-O'Neal Highway, About two and one-half miles northwest from the City of Greer, being all of lot n . 13 on Plat No. 2 of the R.B. Mason Estate, prepared by H.L. Dunahoo, Surveyor, on August 17, 1947, to be hereafter recorded and having the following courses and distances, to wit:

BEGINNING on an iron axle, corner with M A. Mason, being the southeastern corner of the lot herein conveyed, and runs with M.A. Mason line N. 2.20 E. 200 feet to a stake, corner of Lot No. 12; thence with the common line of Lots 12 and 13 in a westerly direction 210 feet to a stake on the east side of the Greer-O'Neal Road; thence along and with the east side of said highway 217 feet to a stake; thence with M.A. Mason's line S. 87.30 E. 114 feet to the beginning corner, containing .65 of an acre, more or less.
