All that piece, parcel or lot of land in Oneal Tewnship, Green-ville County, State of South Carolina, lying on the West side of the Greer-Landrum Road, about two and one-half miles North from the Tewn of Greer, and being the Eastern portion of Lot No. 6 as shown on a plat by H. S. Brockman, Surveyor, dated May 24, 1939, and having the following courses and distances, to wit:

Beginning at a point in the center of the said Greer-Landrum Highway, joint corner of Lots Nos. 5 and 6 on said plat, and running thence along the line of Lot. No. 5, N . 87.30 W. 156.5 feet to a point; thence S. 2.30 W. 209.3 feet to a point on line of Lot No. 7; thence along the line of Lot.
