ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of Galphin Drive and on the Southwest side of Cyrus Court, near the City of Greenville, in Greenville County, S.C., being shown as Lot No. 2 on plat of property of John G. Wilson, made by Dalton & Neves, Engineers, January 1954, recorded in the RMC Office for Greenville County, S.C. in Plat Book W, page 163, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Galphin Drive, at joint front corner of Lots 1 and 2, and running thence along the line of Lot 1, S. 58-08 E., 168.7 feet to an iron pin; thence N. 29-56 E., 102.3 feet to an iron pin on the Southwest side of Cyrus Court; thence along Cyrus Court, N. 49-14 W., 14.2 feet to an iron pin; thence continuing along Cyrus Court, N. 60-09 W., 119.2 feet to an iron pin; thence with the curve of Cyrus Court and Galphin Drive (the chord being S. 77-51 W., 37.1 feet) to an iron pin on the Southeast side of Galphin Drive; thence along Galphin Drive, S. 35-51 W., 75 feet to the beginning corner.
