## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Leo Jones and Melissie Jones,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Two Hundred and Sixty -----

DOLLARS (\$ 260.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs

Township, located on the south side of Ashmore Street, in the Needmore section, being all of Lot No. 19 on a plat of property made for H.J. Lanford recorded in Plat Book F, page 175, R.M.C. Office for Greenville County, and having the following courses and distance, to-wit:

BEGINNING on a stake, joint corner of Lots Nos. 19 and 20 on the south side of Ashmore Street, and runs thence S. 76 E. 50 feet to a stake, corner of Lot No. 18; thence S. 5-20 W. 168.4 feet to a stake; thence N. 72 W. 50.3 feet to a stake, corner of Lot No. 20; thence N. 5-20 E. 157.5 feet to the beginning.
