NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land in Greenville County, State of South Carolina, in the City of Greenville, being known and designated as lots # 48 and 49, of East Lynne, recorded in the R.M.C. Office for Greenville County in Plat Book H at Page 195, and according to a recent survey prepared by J. C. Hill on July 9, 1959, is described as follows:

BEGINNING at an iron pin on the southern side of Airport Road, front corner of lots # 49 and 50, and running thence with the line of lot # 50, S. 9-14 E. 167.3 feet to an iron pin; thence S. 81-02 W. 50 feet to an iron pin; thence with the line of lot # 47, N. 9-14 W. 167 feet to an iron pin on Airport Road; thence with said road, N. 80-43 E. 50 feet to the point of beginning.
