Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain lot of land in Greenville County, State of South Carolina, near the City of Greenville, being known and designated as lot # 125, of a subdivision known as Oakcrest, as shown on plat recorded in Plat Book GG at Page 131, and more particularly described according to survey made by Joseph P. Rostron, as follows:

BEGINNING at an iron pin on the northern side of Lynhurst Drive, front corner of lot # 126, and running thence with the line of said lot, N. 29-12 E. 150 feet to iron pin; thence N. 60-48 W. 70 feet to an iron pin in the line of lot # 124; thence with the line of said lot, S. 29-12 W. 150 feet to an iron pin on said Drive; thence with said Drive, S. 60-48 E. 70 feet to the point of beginning.
