C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile north from Taylors, being a part of tract No. 1 as shown on Plat of Property of Central Realty Corporation, plat made by J. MacRichardson November 1942, said plat recorded in Office of R. M. C. for Greenville County in Plat Book "K" at page 143 and having the following courses and distances, to wit:

BEGINNING on a stone, old corner, and joint corner of the former Boyce Bridwell land, and runs thence with the common line of lots 1 and 2 as shown on said plat N. 11-36 E. 221.3 feet to a stake in a new road (iron pin back on line at 21.3 feet); thence with the said new read, S. 76-48 W. 400 feet to an iron pin on the south side of the said new road; thence a new line, S. 18-45 E. 319.6 feet to an iron pin on the former Boyce Bridwell line; thence with the said line, N. 53-45 E. 302 feet to the beginning corner, containing Two (2) and no/100 acres, more or less.
