## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Jack E. Cox and Lois K. Cox,

Greenville, South Carolina , hereinafter called the Mortgagor, send(s) greetings:

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the Eastern side of Stratford Road in Gantt Township, near the City of Greenville, being known as the Southern portion of Lot No. 87 of South Forest Estates according to a plat made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the R.M.C. Office of Greenville County, South Carolina in Plat Book "GG" at page 181, and having, according to said plat, the following metes and bounds, to-wit:
