MORTGAGE OF REAL ESTATE COUNTY OF... GREENVILLE To All Whom These Presents May Concern: We, H. R. Mulkey and Amy A. Mulkey, of Greenville County, WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Ten Thousand, Eight Hundred & no/100 (\$10,800.00 Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes secured hereby), said note to be repaid with interest at the rate specified therein in installments of 77.39 Seventy-Seven and 39/100 - - -(S. each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 20 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same he plead in the hards of an attorney for collection, or if said debt, or any part thereof. a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note reference, being the proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 25 according to a plat of property of Forestdale Heights prepared by R. K. Campbell, Surveyor, December 1956 revised November 1958, recorded in the R. M. C. office for Greenville County in Plat Book KK, at page 199 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northern side of Forestdale Drive at the joint front corner Lots Nos. 24 and 25, and running thence with the line of Lot No. 24, N. 4-31 E. 200 feet to an iron pin, the joint rear corner of Lds Nos. 24 and 25; thence with the rear line of Lot No. 25, S. 85-29 E. 70 feet to an iron pin, the joint rear corner of Lots Nos. 25 and 26; thence with the joint line of said lots, S. 4-31 W. 200 feet to an iron pin on the Northern side of Forestdale Drive, the joint front corner Lots Nos. 24 and 25; thence with the northern side of said drive, N. 85-29 W. 70 feet to the point of beginning; being the same conveyed to us by J. H. Mauldin by deed of even date, to be recorded herewith."
