"All that certain piece parce or lov of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Bates Township, on the southwest side of a public road leading to Travelers Rest, and being shown as lots # 4, 5 and 6 on a plat of the property of Haskell & Agnes Stokes, recorded in Plat Book 00 at Page 45 and described as follows:

BEGINNING at a stake at the southern intersection of said road and a street, and running thence with said County Road, S. 43-10 W. 300 feet to a stake; thence S. 49-50 E. 113 feet to stake, corner of lot # 3; thence with the line of said lot, N. 41-55 E. 294 feet to a stake in road leading to Travelers Rest; thence with the southwest side of said road, N. 47-30 W. 105 feet to the beginning corner.
