WHEREAS, Edward Whitten

of Anderson hereinafter called the Mortgagee, in the full and just sum of Thirteen hundred  
twenty & no/100----- Dollars, evidenced by a certain promissory note in writing of even date  
herewith, which note is made a part hereof and herein incorporated by reference, payable in Sixty monthly  
installments of Twenty two & 50/100----- Dollars  
each, the first installment being due and payable on or before the 20th day of October, 1959,  
with interest at the rate of six per cent. (6%) per annum from the date of maturity of said note until paid, and said Mort-  
gagor having further promised and agreed to pay ten per cent. (10%) of the whole amount due for attorney's fee, if said note  
be collected by attorney or through legal proceedings of any kind, reference being thereto had will more fully appear.

NOW, KNOW ALL MEN, That the said Mortgagor, in consideration of the said debt and sum of money aforesaid,  
and for better securing the payment thereof, according to the terms and tenor of said note, and also in consideration of  
THREE (\$3.00) DOLLARS to them in hand well and truly paid at and before the sealing and delivery of these presents,  
the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant,  
bargain, sell and release unto the said Mortgagee, all that tract or lot of land lying, being and situated in

Greenville County, State of South Carolina and described as follows, to wit:

All that certain piece, parcel or lot of land lying, being and situate  
in the County and State aforesaid, beginning at a point on a public road,  
said point being the Northernmost point of the one-half acre, more or  
less, conveyed to Thomas E. Whitten, Jr. and Martha H. Whitten from  
R. E. Turner, as shown on a plat of Thomas J. Leslie, Registered Sur-  
veyor, dated December 13, 1950, and running thence from said point N 82-  
20 S 242 feet to a stake, thence turning and running N 33 $\frac{1}{2}$  W 60 feet  
to a point; thence turning and running S 82-20 W 242 feet to a point in  
said public road; thence turning and running S 33 $\frac{1}{2}$  N 60 feet to the  
point of beginning. This lot is a portion of a tract containing 51 acres,  
more or less, conveyed unto the grantor herein by deed of Sue Scott Trustee  
for J. Allen Scott by deed dated September 11, 1945 and recorded in the  
office of the Register Deane Conveyance for Greenville County, South  
Carolina in volume 280, at page 158.
