"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in the City of Greenville, on the northern side of East Stone Avenue, being known and designated as Lot No. 15 as shown on plat of property of Mountain City Land and Improvement Company, which plat is recorded in Deed Book VV, Page 543, in the R. M. C. Office for Greenville County, and being more particularly described according to survey and plat by Pickell and Pickell, Engineers, May 15, 1946, as follows:

"BEGINNING at a stake on the northern side of East Stone Avenue, 109 feet east of the northeast corner of Elizabeth Street and East Stone Avenue; thence with line of Lot No. 14, N. 17-45 E. 206.5 feet to a stake; thence with line of Lot No. 34, S. 72-15 E. 54.5 feet to a stake; thence with line of Lot No. 16, S. 17-45 W. 206.5 to a stake on said Avenue; thence with said Avenue N. 72-15 W. 54.5 feet to the beginning."
