Posey's old corner, and runs thence with said Poinsett Street, 70 feet west to Woodward's corner; thence along the Woodward line 209 feet; thence at right angles 70 feet to Posey's line; thence along the line 209 feet to the beginning corner, and being bounded on the north byPoinsett Street, on the east by Robinson, on the west by Boozer, and on the south by property of the First Baptist Church of Greer.
