All that certain lot of land, with improvements thereon, situate, lying and being in Bates Township, Greenville County, State of South Carolina, Beginning at a point in R. P. Grice and Pearl A. Grice's Northern line on the West side of a County hard surface Road crossing R. P. Grice and Pearl A. Grice's property; thence in a Southerly direction with said Road 225 feet to a new corner; thence a new line on R. P. Grice and Pearl A. Grice's land 195 feet in a Northwesterly direction to a new corner; thence a and Pearl A. Grice's land 195 feet in a Northwesterly direction to a new corner; whence a new line 225 feet in a Northeasterly direction to the Beginning and bounded on the North, South and West by other lands of R. AND it is agreed by and between the said parties that in case of default in any of the payments of interest or principal as herein provided for, the whole amount of the debt secured by this mortgage shall become due and payable at once.

AND IT IS FURTHER AGREED, by and between the said parties, that the said Jamos D. Batos, his

Heirs, Executurs or Administrators, shall and will insure the house and buildings on said lot, and keep the same insured from loss or dainage by fire, and assign the Policy of Insurance to the said Modern Homes Construction Com-

pany and in case that I or my hoirs shall, at any time, neglect or fail so to do, then the said Modern Homes Construction Company may cause the same to be insured in their name, and reimburse themselves for the premium and expenses of such insurance, together with interest on the amount so paid, at the rate of Six (6%) per cent, per annum, from the date of such payment, under this Mortgage.

AND IT IS FURTHER AGREED AND COVENANTED, by and between the said parties, that until the debt hereby secured be paid, the said Mortgagor his Heirs, Executors, Administrators or Assigns, shall and will pay all taxes on the property hereby mortgaged, when due and payable, and in case said mortgagor(s) shall fail to do so, the said Mortgagoe, its Executors, Administrators or Assigns, may pay said taxes, together with any costs or penalties incurred thereon, or any part thereof, and reimburse itself for the same, together with interest on the amount so paid, at the rate of Six (6%) per cent, per annum, from the date of such payment, under this Mortgage.
