NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3:00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Parker Road, and having, according to the plat of the property of J. E. Farr Estate, made by R. K. Campbell, July 25, 1961, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Parker Road, at the joint corner of the Farr property and property owned by Darnell, and running thence N. 56-0 E. 672.6 feet to old iron pinin line of property owned by H. B. Cureton; thence with line of said property S. 43-26 E. 187.4 feet to old iron pin; thence with the line of property of Ruth Hunt Hayes S. 56-30 W. 702.5 feet to pin on Parker Road; thence with the northeastern side of Parker Road N. 34-22 W. 191.5 feet to the point of beginning.
