NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aloresaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate lying and being in the State of South Caroling, County of Greenville, situate on the Southern side of Berea Drive, in Paris Mountain Township, and having, according to a plat of the property of Edith Huff Blakely, made by J. C. Hill on November 20, 1961, the following mates and bounds:

BEGINNING at an iron pin on the Southern side of Berea Drive at the joint corner of property of the mortgagor and Martha Gallman and running thence along the Southern side of Berea Drive, N. 53-05 E. 56.5 feet to a pin; thence continuing N. 41 E. 56.5 feet to an iron pin at the corner of other property owned by the mortgagor; thence with the line of said property, S. 51-20 E. 200 feet to pin; thence S. 48-30 W. 190 feet to a pin in line of Gallman property; thence with the line of Gallman property, N. 29 W. 200 feet to the point of Beginning.
