All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being on the Southern side of Harvley Street in the City of Greenville, County of Greenville, State of South Carolina, and having the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Harvley Street, which iron pin is located 250 feet in an Easterly direction from the Southeastern corner of the intersection of Rutherford Street and Harvley Street, and running thence with the line of property now or formerly of Dr. J.G.
