NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto, the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the south side of Gordon Street, in Judson Mills No. 2 Village, designated as Lots 1, 2, 3, 4, 5 and 6 of Block 'At, according to plat by Dalton & Neves, Engineers, in March 1939, recorded in Plat Book K, at Pages 1 and 2, together with that piece of land shown on said plat as an alley running in the rear of the lots above mentioned, and having together according to said plat the following metes and bounds, to-wit:

**BECINNING at the southeast corner of the intersection of Gordon Street and Georgia Avenue, and running thence with Gordon Street, N. 71-13 E. 214 feet to an iron pipe; thence S. 0-09 E. 84.4 feet to an iron pipe; thence S. 72-13 W. 200.4 feet to Georgia Avenue; thence with Garges Avenue, N. 9-24 W. 80.8 feet to the point of beginning."

ALSO: "All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 10 on plat of property of N. H. Harris, made by R. E. Dalton, July 1920, recorded in the R.M.C. Office for Greenville County in Plat Book E at Fage 257, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at a point on the eastern side of Georgia Avenue, joint front corner of Lots 10 and 11, and running thence with the line of said lot, N. 71 E. 200.4 feet to a point in line of P. and N. Right-of-Way; thence with said Right-of-Way, S. 2-45 E. 85 feet to rear corner of Lots 9 and 10; thence with the line of said lots, S. 71 W. 190.4 feet to a point on Georgia Avenue; thence with Georgia Avenue, N. 9-30 W. 82.8 feet to the point of beginning."

Being the same property conveyed to the mortgagor by deed recorded in Deed Book 641 at Page 426.
