WHEREAS, the Mortgagor is well and truly indebted unto Oneal Insurance Company

, a corporation organized and existing under the laws of South Carolina , hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Six thousand seven hundred Dollars (\$6,700.00) with interest from date at the rate of five and one-fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Oneal Insurance Company in Greenville, South Carolina or at such other place as the holder of the note may designate in writing, in monthly installments of Forty-five and 16/100 Dollars (\$ 45.16), commencing on the first day of January , 19 52, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December , 19 51.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina on the eastern side of Townes Street, in ward one of the City of Greenville, and having the following metes and bounds, to wit:

Beginning at a stake on Townes Street, corner of lot now or formerly owned by Harry Watson, and running thence with the eastern side of Townes Street N 0-28 E 47.2 feet to corner of lot, formerly owned by W. A. Reynolds; thence with the line of said lot S 03-18 E 102.7 feet to stake; thence S 0-37 W 48 feet to stake; thence N 03-18 W 107.8 feet to the joint of beginning.
