The Mortgagor covenants and agrees as follows:

- 1. That he will promptly pay the principal of and interest on the indebtedness exidenced by the said note, at the times and in the manner therein provided.
- 2. That this mortgage stall secure the Mortgagee for such further sums as may be advanced, hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums public assessments, or other put sets pursuant to the covenants herein; and that all sums so advanced shall bear interest at the same rate as the Mortgage debt and shall be payable on demand of the Mortgagee, unless otherwise provided in writing.
- 3. That he will procure and continuously maintain fire and such other hazard insurance as the Mortgagee may require on the improvements now or hereafter on said premises; and will, pay promptly when due any premiums therefor. If he fails to do so, the Mortgagee may cause the same to be done and reimburse itself for such premiums and expenses, with interest theron at the rate of six per centum (6% L.per annum from the date of such advance and the same shall be secured by this mortgage. All insurance shall be carried in companies approved by the Mortgagee and the policies and renewals thereof shall be held by the Mortgagee and have attached thereto loss payable clauses in favor of and in form acceptable to the Mortgagee. In event of loss Mortgagor will give immediate notice by mail to the Mortgagee, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to the Mortgagor and Mortgagee jointly, and the insurance proceeds for any part thereof, may be applied by the Mortgagee at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged.
- 4. That he will keep all improvements now existing or hereafter erected upon the mortgaged property in good repair, and should he fail to do so, the Mortgagee may, at its option enterupon said premises, make whatever repairs are necessary, and charge the expenses for such repairs to the mortgage debt
- 5. Should the mortgagor desire to insure his life in order to protect his estate against liability for any unpaid balance which may be due here under at his death, and shall assign said policy to the mortgagee, the mortgagor does hereby espressly authorize the mortgagee, at its option, to advance premiums upon said policy or policies and to add such premiums advanced to the balance due on this mortgage
- 6. That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagee, on the flist day of each month, until the indebtedness secured hereby is paid in full, a sum equal to one-twelfth of the annual taxes, public assessments and fire and other insurance premiums, as estimated by the Mortgagee and, on the failure of the Mortgager to pay all taxes, insurance premiums and public assessments, the Mortgagee may at its option, pay said items and charge all advances therefor to the mortgage debt.
- 7. And Mortgagor does hereby assign, set over and transfer unto Mortgagee all the rents and profits accruing from the premises hereinabove described, retaining, however, the right to collect said rents so long as the payments herein set out are not more than thirty; days in afrears, but it all any time any part of said debt, interest, insurance premiums or taxes, shall be past due and unpaid. Mortgagee may provided the premises here in described are occupied by a tenant or tenants, without further proceedings, take over the property herein described, and collect said rents and profits and apply same to the payment of taxes, insurance, interest, and principal, without liability to account for anything more than the rents and profits actually collected, less the cost of collection, and should said premises be occupied by the Mortgagor, and the payments hereinabove set out become past due and unpaid, then Mortgagee may apply to any Judge of the Circuit Court of said State, at Chambers or otherwise, for the appointment of a Receiver, with authority take charge of the mortgaged premises designate a reasonable rent al, and collect same and apply the net proceeds thereof (after paying costs of collection) upon said debt, interest, taxes and insurance, without liability to account for anything more than the rents and profits actually collected.
 - 8. Mortgagor waives the benefit of any appraisement laws of the State of South Carolina.
- 9. It is agreed that the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage of in the note secured hereby. It is the true meaning of this instrument that if the Montgagor shall fully perform all the terms, conditions, and covenants of this mortgage, and of the note secured hereby, that then this mortgage shall be utterly mull and void; otherwise to remain in full force and virtue. If there is a default in any of the terms, conditions or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgages all sums then owing by the Mortgagor to the Mortgagee shall become immediately due and payable and this mortgage may be foreclosed. Should any legal prospectings be instituted for the foreclosurg of this mortgage, or should the Mortgagee become a party to any suit involving this Mortgage of
