"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, Chick Pprings
Township, on the east side of Piedmont Avenue (now Memorial Drive)
in the City of Green, and designated as Lot No. 28 on plat, of MORROW
PARK recorded in Plat Book H, at pages 84-85, R.M.C. Office for
Greenville County, and having the following courses and distances,
to-wit:

BETINGING at iron pin on the east side of Memorial Drive, at junction with Rosa Street, and runs thence with Rosa Street, S. 77-33 E. 150 feet to an iron pin on said street; corner of Lot, No. 49; thence with the line of Lots Nos. 59 and 50, N. 11-45 E. 75 feet to corner of Lot No. 30 on line of Lot No. 50; thence N. 77-33 W. 150 feet to Memorial Drive; thence with said Drive, S. 11-45 W. 75 feet to the beginning corner, bounded on the east by Lots Nos. 49 and 50, on south by Rosa Street, on west by Hemorial Drive and on the north by Lot No. 30.
