TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Guy L. Chapman and Bernice Chapman, (herenafter afetred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagoe) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Hundred -----

DOLLARS (\$1200.00), with interest thereon from date at the rate of S1x (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick prings Township, about one mile south of the City of Greer, designated as Lots Nos. 9, 10 and 11 of Pleasant Heights Development, property of R.A. and I.D. Dobson Estate according to survey and plat thereof by H.L. Dunahoo, Surveyor, dated September 4, 1950, and having the following courses and distances, to-wit:

BEGINNING at a stake on the west side of Oakland Avenue, corner of Lot No. 8, and running thence along the line of Lot No. 8, N. 53-50 W. 200 feet to stake on line of Greene property, formerly I.M. Wood Estate; thence along said line, N. 39-30 E. 300 feet to stake corner of Lot No. 12; thence along the line of Lot No. 12, S. 53-30 E. 200 feet to stake on west side of Oakland Avenue; thence along said Avenue, S. 39-30 W. 300 feet to the beginning corner.
