WHEREAS, the Mortgagor is well and truly indebted wnto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, CREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$18,500.00), with interest the con from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred:

Twenty and No/100 --- Dollars (\$ 120,00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Creenville, being known and designated as Lot 93, Section A, of Gower Estates, recorded in Plat Book QQ at Pages 146 and 147 in the R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds; to-wit:

"BEGINNING at an from pin on the southeastern side of Pimlico Road, joint front corner of Lots 92 and 93, and running thence with line of Lot 92, S. 54-23 E, 170 feet to iron pin; thence S. 18-37 W. 76.3 feet to iron pin at the joint rear corner of Lots 94 and 93; thence with line of Lot 94, N. 67-54 W. 184.9 feet to iron pin on Pimlico Road; thence with said Pimlico Road N. 29-24 E 117.2 feet to iron pin at the point of beginning.

"Being the same conveyed to the mortgagors by deed of Convers & Gower Inc. to be recorded herewith."

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagors agree to pay to the mortgagee as premium for such insurance one-half of one per cent of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture; be considered a part of the real estate.
