"All that certain piece, parcel of lot of land; with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the east side of Lanford Street and the north side of Barbare Street in the City of Green, being Lots Nos. 69, 70 and 71 of Westmoreland Circle, according to survey and plat recorded in Plat Book "T", page 199, R.M.C. Office for Greenville County, and having a frontage of 141 feet on Barbare Street and a frontage of 150 feet on Lanford Street, with a depth of 138 feet on the north side of 150 feet on the east side.

ALSO, ALL that certain parcel or lot of landsituated on the west side of Pine Street in the City of Greer, Chick Springs Township, County and State aforesaid, being Lot No. 50 of the C.M. Hemphill property according to survey and plat by H.S.
