NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the, terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 187 on plat of property of Pineforest Subdivision, prepared by Dalton & Neves, Engineers, August, 1959 and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at pages 106 and 107, and having, according to gaid plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Mapleton Drive at the joint front corner of Lots 186 and 187, and running thence along the joint line of said lots, S. 14-15 W. 195.9 feet to an iron pin in the line of Lot No. 169; running thence along the line of Lot 169, S. 70-48 E. 90 feet to an iron pin on the western side of Vine Hill Road; running thence with the western side of Vine Hill Road, N. 19-12 E. 189.8 feet to an iron pin at the intersection of said Vine Hill Road and Mapleton Drive; thence with the curvature of said intersection, the chord of which is N. 37-08 W. 55.5 feet, to an iron pin on the southern side of Mapleton Drive; thence with the southern side of said Mapleton Drive, S. 86-32 W. 65.8 feet to the point of beginning; being the same conveyed to us by Wooten Corporation of Wilmington by deed dated October , 1962, to be recorded herewith."

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes, and assessments next due on the mortgaged property (all as estimated by the mortgagee) less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by the mortgagee in escrow to pay said premiums, taxes and special assessments. Should these payments exceed the amount of the secretary payments actually made by the mortgagee for taxes, assessments, or
