All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at Travelers Rest, S. C., known as Lots 22 and 23 on plat of Meadowbrook Farms, recorded in plat book "M" at page 105, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Toler Road, approximately 418 feet east of Geer Highway, at the corner of Lot 4, and running thence along Toler Road, N 57-45 E, 200 feet to an iron pin; thence S 29-55 E, 375.5 feet to an iron pin; thence S 57-45 W, 200 feet to an iron pin; thence N 29-55 W, 375.5 feet to the point of beginning and being the same property conveyed to Harold E. Robinson and Lettie H. Robinson in deed book 513 at page 205, and the same to me by their deed to be recorded of even date herewith.
