WHEREAS, I/we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Seven Thousand. Seven Hundrad and No./100 - (\$7,700.00.) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

extended, will be due and payable 18 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the Hy-Laws of said Association, or any of the slipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder day sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee bedde all costs and expenses of collection, to be added to the amount due on aid note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully, appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release; unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"BEGINNING at an iron pin on'the southern side of Sharon Drive, the joint front, corner of lots #8 and #9 and running thence along the line of these lots, S, 14-40 E. 153.6 feet to an iron pin in the line of lot #11; running thence S. 77-17 W. 45 feet to an iron pin at the joint corner of lots #8 #11, #5 and #6; running thence N. 45-25 W. 88.5 feet to an iron pin; thence N. 14-40 W. 77 feet to an iron pin on the southern side of Sharon Drive; running thence along the southern side of Sharon Drive, N. 75-20 E. 97 feet to an iron pin, point of beginning; being the same property conveyed to me by James R. Hall by deed dated March 7, 1962 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 694, at Page 35."
