"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southeastern corner of Parkins Mill Road and Winfield Road being shown and designated as Lot 4 of Section A' on plat of Gower Estates recorded in Plat Book QQ at Pages 146 and 147, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Parkins Mill Road at the joint front corner of Lots 3 and 4 and running thence with Lot 3 s. 58-18 E. 250 feet to pin in line of Lot 5; thence with the line of Lot 5 N. 31-24 E. 160 feet to a pin on Winfield Road; thence with the southern side of said road N. 58-18 W. to pin; thence with the curve of the intersection of Winfield Road and Parkins Mill Road S. 76-42 W. 35.3 feet to a pin on Parkins Mill Road; thence with the eastern side of Parkins Mill Road S. 31-42 W. 160 feet to the point of beginning.
