"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, on the eastern side of a new road that leads from State
Highway No. 14 to and by Matt's Fishing Lake, near Pleasant Grove
Baptist Church, being a part of Tract No. 2 as shown on plat of property
of J.G. Greer, L.B. Vaughn, I.M. Wood and J.A. Wood, said plat
prepared by M.A. Christopher, Surveyor, November 22, 1921, and having
the following courses and distances, to-wit:

BEGINNING on an iron pin on the I.M. Wood Estate line, joint corner of S.J. Harvey and wife's lot, and runs thence with their line, N. 49-50 W. 119 feet to a stake in center of said new road (iron pin back on line at 18 feet); thence with the center of the said road, S. 31-00 W. 152.2 feet to a stake in center of said road; thence S. 49-50 E. 18 feet to an iron pin on eastern bank of road; thence continuing with the same course for a total distance of 93 feet to an iron pin on the said I.M.
