C., its successors and assigns: 4, in consideration of the said debt and sums of money

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Middle Tyger River and having the following metes and bounds, to wit:

BEGINNING at a stake 3x in Middle Tyger River and running thence down said river with meanderings to the mouth of a branch called Middle Branch; thence with the meanderings of said branch to a red oak 3x in a hollow above the head branch; thence N. 12 E., 6.50 to a chestnut oak 3x, 3x on side of the mountain; thence S. 5 3/4 E., 24.20 to a large chestnut 3x; thence S. 3½ W., 11.72 to a Pine 3x; thence South 1½. E., 16.80 to the beginning corner and containing forty four (14) acres more or lessy bounded now or formerly by lands of Bird Eavins, Joseph McKinney and others.
