Office for Greenville County in Plat Book J, at pages 220 and 221 and described as follows:

"BEGINNING at a stake on the southern side of McMakin Drive 534.1 feet east from Parker Road, at the corner of Lot 12 and running thence with the line of said lot, S. 8-28 W. 234 feet to a stake; thence N. 78-10 E. 53.5 feet to a stake; thence S. 86-07 E. 50.2 feet to a stake at the corner of Lot 15; thence with the line of said lot, N. 8-28 E. 211.5 feet to a stake on McMakin Drive; thence with the southern side of McMakin Drive, N. 81-32 W. 100 feet to the beginning corner; being the same property conveyed to me by Thomas J. Christian and Margaret M. Christian dated July 27, 1950 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 415, at Page 210."
